***Re: Spaulding Matters***

Director Bonavolonta:

As you know, I am a whistleblower and have exposed malfeasance in most, if not all, municipalities in Massachusetts. School Committees cannot account for federal, state and private grants they have been awarded. Evidence supports they are also conspiring with board officers of tax exempt nonprofit organizations to illegally fundraise and misappropriate donations.

Natick and Framingham School Committees, our elected officials, do not deny/dispute being involved in malfeasance and public corruption. Natick School Committee does not deny/dispute misappropriating donations to cover up for embezzlement by a former employee; the amount is believed to be over \$20 million dollars.

Framingham School Committee does not deny/dispute being involved in ongoing corruption conspiring with Attorney Mike Barry, counsel for the Town/City Wide Parent Teacher Organization, to illegally fundraise and misappropriate donations. Framingham School Committee had an \$8 million dollar budget deficit in 2010 when I was a board officer and cooperated with the AG.

My family, especially my child, has been retaliate against because of my whistleblower actions; our civil and constitutional rights continue to be violated. Most concerning is neighbors have been enlisted to surveil where my child is sleeping at night; it is undisputed there are images of my child that are pornographic. My child is now fully disabled because of the ongoing abuse and is being denied a free appropriate public education. A hostile environment has been created and maintained which remains so pervasive and severe as to interrupt her educational process; our claims of bullying were never investigated per the law.

I first contacted the FBI in 2017 to no avail; I again met with special agent in 2018 in Charlestown after the ACLU agreed to represent me. In June 2019 I met with Special Agent Jay Ofmanski in the Worcester office; he agreed I had a great case based on the list of witnesses and factual evidence. He then called me from a Needham, MA telephone number and told me "no more emails." I was confused and he said "we don't need anymore emails, we have access to all your emails." When I inquired whether or not there was an investigation he stated "I am not saying we are not investigating." I never heard another word from the FBI other than Attorney Meltzer stating to Judge Yarashus that the FBI was not investigating; apparently he learned this from his relationship with Judge Doug Stoddart and Nadine Pellegrini.

You and DOJ Andrew Lelling were fully aware of the involvement of Judge Doug Stoddart and his wife, Nadine Pellegrini who is an Associate Attorney for the US DOJ, responsible for prosecuting money laundering.

Judge Stoddart does not deny or dispute being involved in the child pornography and conspiracy to deny us our civil and constitutional rights.

January 24, 2020 you and Andrew Lelling along with IRS Special Agent Kristina O'Connell at a media event appealed to the public for assistance in combating public corruption ***"The FBI encourages anyone who encounters or suspects municipal malfeasance to report it, and to help us to hold those who violate taxpayers' trust accountable."*** Andrew Lelling said ***"This office will aggressively prosecute any public official, regardless of party or position, whose greed leads them to breach the public trust and break federal law."*** IRS Special Agent Kristina O'Connell said ***"Today's sentencing should serve as a reminder to those who seek to violate the public's trust that you will be held accountable for your actions."***

June 2020 I was in Superior Court before Judge Valerie Yarashus as Plaintiff against my neighbor Karen Vaz who one of the abutters conspiring with both Framingham and Natick to deny us our civil rights. Ms. Vaz and her husband, Paul Vaz, as well as Avi and Suzanne Finder are represented by Attorney Robert N. Metlzer. Attorney Meltzer committed fraud upon the court; I have contacted Superior Court Judge Yarashus and she does not deny or dispute her being a co-conspirator to fraud upon the court, a co-conspirator to obstruct justice.

Natick Police Chief James Hicks does not deny or dispute his being a co-conspirator; fully aware and complicit with the child pornography, municipal malfeasance, public corruption, obstruction of justice, failure to keep a child from harm, conspiracy to deny civil and constitutional rights. Chief Hicks was a bad actor since August, 2014 when I first contacted him regarding this matter.

Superior Court Judge Josh I. Wall does not deny/dispute being a co-conspirator and confirmed he has a relationship with Chief Hicks; his loyalty to Chief Hicks superseded his loyalty to justice, to my child. Superior Court Judges Bruce S. Henry, Camille Sarrouf, Maureen Hogan just to name a few, do not deny or dispute their involvement in a conspiracy to deny us our civil and constitutional rights. Governor Baker and his executive board do not deny or dispute being bad actors, co-conspirators to child pornography, obstruction of justice, denial of civil rights.

State Senators Karen Spilka, Brownsberger, Lovely, Lesser, Rausch and numerous others are fully aware and complicit are Representatives. U.S. Senators Warren and Markey do not deny/dispute being co-conspirators to deny us our civil rights, child abuse/child pornography, public corruption.

U.S. Representative Katherine Clark and her husband, Rodney S. Dowell, do not deny/dispute being co-conspirators to the denial of civil rights, child abuse/pornography, denial of a FAPE, etc. Juvenile Court Judge Gloria Tan does not deny/dipsute being a co-conspirator with Natick School Committee and Child Advocate Maria Mossaides who repeatedly threaten to remove my child from my custody if I didn't stop my whistleblower actions. Most recently this past February 26, 2021 when I contacted via email the committee to nominate Andrew Lelling's replacement; Ms. Mossaides inferred I was mentally unstable. She went so far as to file a wellness check with Framingham Police Department based on the "quantity of emails" which were two (2).

While I was in Superior Court in June, 2020 you and Attorney Lelling were standing with Chief Hicks lauding him with superior detective work regarding another matter. It appeared you were

giving him validity against my claims of his involvement as a co-conspirator to deceive public trust.

I had file a complaint with the DOJ against you and Andrew Lelling for you involvement in public corruption and was told by Attorney Ragsdale's office they do not investigate "school departments." I filed another complaint and explained the perpetrators were elected officials, School Committees, and asked for an investigation.

I corresponded with US DOE OCR Attorney Peter Gelissen and copied DOE Inspector General Sandra Bruce; both are fully aware and complicit with the retaliation of a whistleblower's family. Fully aware my child was bullied/abused by educators to the point of suicidal ideation and now is fully disabled. The municipal malfeasance was never investigated nor was the claims of bullying; it is unsafe for my child to return to public schools until resolution **(Exhibits: A, B, C)**.

Duly noted, teachers' unions and local police unions are also not in compliance with federal and state laws. Why did the FBI decide not to protect my child from such abuse? Why did you not do your job - was it because of the involvement of US Associate Attorney Nadine Pellegrini and her husband, Doug Stoddart? Was it because of the child pornography, or because Andrew Lelling had political ambitions and needs the unions votes?

This is a matter of public trust. What happened to my child will happen to "anyone" any child, any citizen/parent who simply questions financial practices in municipalities. We cannot obtain the images of my child that are pornographic without the assistance of the FBI. I first filed my complaint with the FBI because we have been repeatedly lied to by our elected officials, and the court administration, state officials are complicit; it is a crime to lie to the FBI.

As you know, I am fully disabled as well; please accommodate my disability and ask for clarification as the ongoing stress has caused "brain fog." I have a website [JusticeforSarahC.com](http://JusticeforSarahC.com) (Wordpress blog) where I will be uploading/downloading documents for accuracy, accountability and transparency.

I have filed a compliant with US Attorney General Merrick Garland and Senate Judiciary Committee to have this matter properly investigated. Inspector Generals: Sandra Bruce, Christi Grimm and Michael E. Horowitz are all aware and complicit.

My child should have graduated from high school this past June; she has the emotional age of a 12 year old, barely a 10th grade education, has PTSD, Agoraphobia, and cannot self advocate to self preserve. She has a legal right to a FAPE (free, appropriate, public education) until the age of 22.
