RE: FRAUD UPON THE COURT -SPAULDING CHILD  
SENT: CERTIFIED US POSTAL MAIL

Judge Henry:

You presided over several matters involving Spaulding v. Natick, Spaulding v. Finder, Spaulding v. Vaz, Spaulding v. Framingham - from May, 2015 to September, 2019. The matter involved a minor child who was being retaliated against by school committees; excluded based on residency. You refused to recuse yourself.

The residency investigation included my neighbors taking pictures of my child in her bedroom; we have repeatedly been denied "due process" the evidence, the pictures.

I had cooperated with the AGO in an investigation into municipal malfeasance in Framingham involving the parent teacher organizations to which I was a board officer. Members of the community complained about how the donations were being processed. I learned of malfeasance involving the school committee. The AGO upheld the findings and the school committee retaliated by excluding my child, forcing us to transition to Natick Public Schools where her father lives.

I inadvertently learned that Natick School Committee was also involved in municipal malfeasance; in fact, a former employee confirmed there was embezzlement. I spoke at the Board of Education in September, 2020 and Secretary of Education Jim Peyser did not deny their part in the fraud upon the court. Nor did he deny the amount thought to be over 10 million dollars. This appears to be the cause of the retaliation and abuse set forth upon my child.

The matter was reported to the FBI but apparently because a US Federal Attorney, Nadine Pellegrini, is involved, they are not prosecuting. Senate President Karen Spilka as well as US Representative Katherine Clark amongst other legislators are complicit.

Were you a "bad actor" involved in committing fraud upon the court or were you a victim of the fraud? Regardless of your response, this is the worse case of fraud upon the court ever seen.

I am aware that if you are in possession of the pictures of my child that were taken by neighbors during the residency investigation, you will not admit it. I need to know your involvement with harm to my child.

It is quite unusual for a former litigant to write to a retired judge, my duty to my child is paramount. It is not my desire to in any way give you concern for your safety and will only contact you via US postal mail with the FBI copied.

I plead with you to respond with an honest answer so that I might resolve this 7 years of conflict and help my child heal. We need to know the truth; she needs to know she was not to blame. She is not in school, not being adequately educated; she has agoraphobia and a service dog. I cannot in good faith allow her to walk in the neighborhood because of ongoing valid concerns with neighbors' agenda. She has incredible potential and I seek to help her fully realize her potential for a meaningful life - a fully functioning member of society.

I am disabled with autoimmune and not in remission; medications and disease causes mental confusion. Please accommodate and ask for clarification if needed.
