Dear Attorney General Garland:

I am a whistleblower who has exposed ongoing municipal malfeasance in most, if not all, Massachusetts communities; my family, my child, has been retaliated against because of my actions. My child was bullied/abused by town/city officials and their agents to the point she is now fully disabled and suicidal. I have also become fully disabled with autoimmune disease due to the ongoing stress.

School Committees cannot account for millions granted to them by federal, state and private organizations. School Committees also conspire with board directors of nonprofit tax exempt charitable organizations to illegally fundraise and misappropriate donations.

In 2010 I learned of malfeasance within the Framingham TownWide and Barbieri Elementary Parent Teacher Organization “PTO” and reported this to the Attorney General Investigator Dan Ferullo. As a board director, I had a legal duty to report; our attorney, Mike Barry, and other board directors chose to continue to conspire with the school committee. Framingham School Committee then excluded my child based on residency MGL c. 76 s 5; they required all students sleep full time in Framingham.

2013, My child transitioned to Natick Public Schools where I inadvertently learned Natick School Committee was also involved in malfeasance. They were also conspiring with board directors of nonprofits to misappropriate donations and grants. Natick also excluded my child based on residency. Per court documents, Natick School Committee (through their agents) claimed to have evidence from my neighbors in Framingham that my child was not sleeping in Natick 50% of the time per their residency policy. We were denied “due process” the evidence used to exclude her. It is undisputed that Natick School Committee conspired with my neighbors to conduct surveillance on my child; it is undisputed these images are of my child nude/undressed in her bedroom. These images are classified by the FBI as pornographic. Natick’s Police Chief James Hicks is complicit, a bad actor, co-conspirator.

Evidence supports that Governor Charlie Baker and his executive board including Secretary of Education, Jim Peyser; Commission for the Department of Children and Families, Linda Spears, Child Advocate Maria Mossaides, Health and Human Secretary Marylou Sudders and others are also complicit. Massachusetts AGO Maura Healey was also a co-conspirator, refusing to open a civil rights complaint, fully aware of most, if not all, school committees engaged in fraud. Natick’s Superintendent Anna Nolin, circulated a document (**Exhibit A**) to all Superintendents warning them that I am alerting fellow board officers of the fraud.

Further evidence supports the Massachusetts Courts are also involved; Superior Court Judges Bruce S. Henry, Josh I. Wall, Valerie Yarashus, to date, do not deny/dispute being “bad actors” fully aware and complicit with fraud upon the courts. Juvenile Court Judge Gloria Tan does not deny/dispute being a bad actor also involved in fraud upon the courts; ordering my child back to the same environment in Natick Schools that she knew led to her suicidal ideation and disability. District Judge Doug Stoddart does not deny/dispute being a bad actor and committing fraud upon the courts in giving my neighbor a restraining order against me that did not meet the standard of law. Judge Doug Stoddart and his wife, US Associate Attorney Nadine Pellegrini do not deny/dispute being co-conspirators to child pornography, harm to a disabled child, violating our civil/constitutional rights.

Superior Court Judge Josh I. Wall had recused himself because of his relationship with Natick’s Police Chief James Hicks; however, he returned to the bench in November, 2015 to dismiss my claims with prejudice. My child had succumb to the hostile environment and wrote “I would rather be dead than go back to that school.” Natick was allowed to restrict a parent’s (or both parents’) right to effectively advocate for their disabled child based on the quantity of email a parent has sent to teachers. It is undisputed the quantity of emails I sent was 4 innocuous emails over a 10 month period. It is my understanding that the US DOE OCR (**Exhibit B**) found this to be a violation of our civil rights but could not overrule a superior court judge. I have enclosed my letter to Judge Wall; again, he does not deny/dispute being a co-conspirator to deny us our civil and constitutional rights, committing fraud upon the courts (**Exhibit C**).

In 2017, I wrote to then FBI Director Harry Shaw about my concerns but received no reply. I wrote to FBI Director Joseph Bonavolonta and received no reply. Former US Attorney, Andrew Lelling did reply to my numerous letters and stated he would not prosecute because the FBI did not refer the matter to his office.

In 2018, I reached out to Senator Elizabeth Warren - who had already declined my ex-husband, John Spaulding’s request for assistance. Senator Warren’s regional director Farrah Ridore finally agreed to meet with my child and I in September, 2019. It was awful, Ms. Ridore had the gall to tell my child to her face that she didn’t think my daughter was really bullied, went on to say that Senator Warren was fully aware but needed the support of AG Maura Healey and would not be assisting us with federal agencies such as the US DOE or DOJ.

Massachusetts Chief Counsel for Board of Bar Overseers, Rodney Dowell, husband of Representative Katherine Clark, also aware and complicit with numerous attorneys acting as bad actors, violating the standard rules of professional conduct.

I met with Representative Katherine Clark’s aide Jay Higgins in October, 2019 and Mr. Higgins also stated that Rep. Clark was fully aware of the situation and was unwilling to help. My child had come up with a brilliant idea to allow anyone who felt unsafe in a school to text/email a national line. This would accommodate disabled students like my child who could not speak and would also serve as written documentation of an unsafe situation. This data could then be used to better direct resources in the towns/districts. We had hoped that this new law would have helped with my child’s ability to get into college; Mr. Higgins stated that Rep. Clark was no longer interested in helping us. It is undisputed that Rep. Clark is a bad actor; fully aware of the public corruption in Natick and Massachusetts and the ongoing retaliation (**Exhibit D**).

January 24, 2020 per media account, US DOJ Attorney Andrew Lelling, FBI Director Bonavolonta, and then IRS Investigator Kristina O’Connell all repeatedly encouraged the public to assist them: **“The FBI encourages anyone who encounters or suspects municipal malfeasance to report it, and to help us to hold those who violate taxpayers’ trust accountable.”**

June 15, 2020 while I am in Superior Court asking for my neighbors to cease conspiring with Natick in ongoing harassment and civil rights violations; Joseph Bonavolonta and Andrew Lelling are publicly commanding Natick Police Chief James Hicks on outstanding detective work: ***"This is a good example of something that should be blindingly obvious that our local police actually do spend their time trying to keep our communities safe," Lelling said, announcing charges against six former eBay executives who orchestrated a targeted cyber harassment campaign against a Natick couple and praising the Natick Police Department for its role in uncovering an elaborate scheme.***

Attorney Lelling and Special Agent Bonavolonta are fully aware that Natick's Police Chief James Hicks was a bad actor, co-conspirator to covering up the child pornography, embezzlement, public corruption. Duly noted, my neighbors attorney, Robert N. Meltzer, was retained by and conspired with Natick Town Officials including police, school and select board.

I also filed complaints with the Inspector Generals of the HHS, DOE and the DOJ; I did not hear back from Christi Grimm or Sandra Bruce but per emails from their departments, they are aware. I did not hear back from Michael E. Horowitz either but did receive a response from the US DOJ Office of Professional Responsibility "OPR" falsely claiming they don't have jurisdiction over public schools. They do have jurisdiction over elected officials, members of the school committee (per state statute it is the school committee who has authority to exclude a child from attending based on residency and has the legal authority to accept grants). My response letter to the OPR fell on deaf ears. September 1, 2021 I received a letter from the US DOJ FBI Inspection Division, Internal Affairs Section (IAS) who declined to investigate my allegations involving US Attorney Andrew Lelling, US Associate Attorney Nadine Pellegrini and FBI Director Bonavolonta.

No word as of yet on why the child pornography, embezzlement, conspiracy to deny civil rights, obstruction of justice, public corruption, etc. are not being investigated - My US Senators and Representative are refusing to correspond with us to resolve our concerns.

February 26, 2021 I sent an email to the committee to nominate US Attorney Andrew Lelling's replacement with my concerns and supporting documentation. Governor Baker's Child Advocate, Maria Mossaides, filed with the Framingham Police a "wellness check" claiming she was concerned for my child's safety based on the quantity of emails I had sent that day (**Exhibit E**).

Senators Warren and Markey are aware and complicit; I am aware that Senator Warren attended a campaign for re-election event for Framingham's Mayor Spicer. Senator Warren is aware and complicit with the child pornography, ongoing public corruption, harm to my child, continued conspiracy of civil and constitutional rights (**Exhibit F**).

I most recently filed a compliant with Inspector General J. Russell George, Treasury Inspector General Tax Administration. I have already filed numerous #13909 IRS forms regarding this ongoing fraud of nonprofits.

The IRS audited Boston Public Schools in 2019 and found numerous significant violations. Educator Abuse is also at an all time high. Again, Secretary of Education Jim Peyser and former Board of Education Chair Paul Sagan does not deny/dispute my claims of child pornography, embezzlement, conspiracy to deny civil rights, etc.

MA Board of Education past chairman, Paul Sagan and current BOE Chair refer me to their attorneys, Rhoda Schneider and Josh Varon, where I am told “our job is not to help your child but to protect our client, employees of the Education Department from liability.”

Paul Sagan is very well connected with the media; it is undisputed he is using his influence to keep this matter quiet. His philanthropy has donated large sums of money to both the ACLU and the New England Coalition for First Amendment. The ACLU had represented me in a 2018 lawsuit against Natick; their senior attorneys do not deny/dispute being complicit with the abuse of my child, public corruption, denial of civil/constitutional rights, etc.

My child has now lost her benefits from Social Security because she is not enrolled in a public school; Senator Warren and Markey, Representative Clark are refusing to respond to my requests for assistance. It is futile to retain an attorney for representation because of the bad faith of court administration.

My child became suicidal again this past June and was hospitalized at Newton Wellesley Hospital; they diagnosed her with psychosis stating it was “implausible that the neighbors would be spying on her for the schools.” My attempts to resolve this with the psychiatrists left them more entrenched in their belief that I am a bad influence on her; again, threatening to involve DCF. Attorney Garland, what becomes of my child?

I am respectfully requesting you re-open this closed case involving corruption of DOJ employees including FBI Director Joseph Bonavolonta, Andrew Lelling and Nadine Pellegrini. I recently encountered Ms. Pellegrini’s husband, Judge Doug Stoddart, in a store - he continues to not deny/dispute being a bad actor involved with child pornography of my child (**Exhibit F**).

We cannot get the pornographic images of my child returned to us without the assistance of the FBI.

This is a matter of public trust; what happened to my family, my child will happen to anyone who reports or suspects municipal malfeasance. Whistleblowers have a right to be protected from retaliation; all I did was comply with the law and reported malfeasance within tax exempt organizations.
