Honorable Scott and Ranking Member Foxx et al:

My child and I are requesting an investigation (not adjudication) of ongoing fraud in most, if not all, school committees in Massachusetts as well as the Department of Education who receives and distributes federal funds via grants to school districts. This is not an individual claim but systemic and widespread fraud, waste, abuse of power and public corruption. You are not an administrative court or a court of law, but you are a congressional committee with investigatory powers: ***"Chief Justice Warren did not question the basic power. "The power of the Congress to conduct investigations is inherent in the legislative process. That power is broad. It encompasses inquiries concerning the administration of existing laws as well as proposed or possibly needed statutes. It includes surveys of defects in our social, economic or political system for the purpose of enabling the Congress to remedy them. It comprehends probes into departments of the Federal Government to expose corruption, inefficiency or waste."***

1. The inspector general publicly implores "anyone who knows of or suspects fraud to report it" - I reported fraud and my child was abused by educators to the point she became suicidal at the age of 12 and required hospitalization. She is now fully disabled and is denied a FAPE. Natick and Framingham School Committees do not deny fraud involving federal funds.
2. My Rep. Katherine Clark as well as Senators Warren and Markey do not deny or dispute my claims; they are co-conspirators and fully complicit with public corruption. They refuse to even correspond with my child and I to resolve

this matter without congressional interference. My child is suffering. As attorneys they are fully aware of the ongoing fraud and have chosen to not act in the best interest of their constituents.

3. In Massachusetts, by law, School Committee members must receive training from the Massachusetts Association of School Committee "MASC" whose president is Beverly Hugo, Framingham School Committee member since 2003 and fully complicit with ongoing fraud, conspiracy to deny civil liberties and rights, abuse/harassment of a disabled person, obstruction of justice, etc.

4. M.G.L. c. 71 s 37a and c. 44 s 53a require a school committee to accept and control grants; however, this law is crafted into a policy which allows a superintendent to control the federal funds.

5. Massachusetts Governor, his Secretary of Education and Board of Education Chair as well as AG Maura Healey are all aware that school committees in Massachusetts cannot account for federal funds. More concerning is if "anyone" suspects fraud and questions their school committee, they and their children are retaliated against and there is no investigation, no remediation.

6. Both Framingham and Natick School Committees per MGL c. 76 s 5 excluded my child based on residency; a non fraudulent claim to residency, my child split her time between 2 school districts (I live in Framingham and my ex-husband lives in Natick) - per the DESE 2005 advisement and 2014 decision by DESE #14-1028 "if a student splits their time between 2 school districts, the parents have the right to choose which school district for their child to attend." Both times we were denied "due process" our federal right to the evidence. It is undisputed that my neighbors were co-conspirators and were conducting surveillance of my child in her bedroom (on weekends) and these images of my child are considered pornographic; she is nude/undressed. To date, we have been unable to obtain these images, by law, we need the FBI assistance.

7. Framingham School Committee does not deny/dispute they had an \$8 million dollar budget deficit and was intentionally defrauding the community via conspiring with board officers of PTOs to illegally fundraise and misappropriate the tax exempt donations. I complied with the law and reported my concerns to the AG. Framingham created and maintained a hostile environment and then excluded her based on residency - they conducted an investigation when it was known I was in the hospital for a disability related illness for 3 days.

8. The Natick School Committee does not deny or dispute a former employee embezzled what is believed to be over \$20 million dollars during the construction of the new Natick High School. They do not deny or dispute creating and maintaining a hostile environment so pervasive and severe as to cause my child to become suicidal and is now fully disabled. Framingham and Natick School Committees do not deny or dispute ongoing fraud and hostility.

9. My child continues to be denied a FAPE, federal violation, because the bullying/abuse has never been investigated and remediated.

10. The Natick School Committee did a residency investigation with the Natick Police which confirmed she was seen in Natick with her father 50% of the time, fulfilling Natick's residency requirement. Chief of Police violated the law and refused to provide the evidence, we were denied a complete school record (violation of FERPA),

11. Rep. Katherine Clark does not deny or dispute that she and her husband, Rodney Dowell, Chief Counsel for the Board of Bar Counsel who oversees attorneys conduct are fully aware and complicit with fraud and public corruption. Numerous attorneys have declined citing public corruption "we will never win another case if we represent you" or other attorneys act in bad faith, violating standard rules of conduct.

12. Natick and Framingham Attorneys, along with numerous others, do not deny or dispute they are acting in bad faith, fully aware their clients are involved in ongoing fraud and public corruption, including "fraud upon the courts."

13. Natick does not deny or dispute they conspired with the DCF Commissioner and General Counsel Andrew Rome to file for Care and Protection falsely claiming I was so mentally unstable I was falsely claiming my child was not safe in Natick Schools. I have no diagnosis of mental illness other than the ongoing stress.

14. Natick School Committee and their attorneys do not deny or dispute submitting falsified attendance records to court and conspiring with Juvenile Court to commit fraud upon the courts in order to obtain a court order - Chief Justice Amy Nechtem does not deny or dispute her involvement in obstruction to justice.

15. US DOJ Associate Attorney Nadine Pellegrini and her husband, former Judge Doug Stoddart do not deny or dispute their complicitness in the fraud, obstruction of justice, child pornography, conspiracy to deny civil

rights, obstruction of justice. They live in Natick - Ms. Pellegrini is responsible for prosecuting money laundering. Judge Doug Stoddart gave one of my neighbors a restraining order which did not meet the standard of law: 2 letters requesting neighbor cease trespassing onto my property and a photo of neighbor harassing us.

16. Last June, my child was again hospitalized after yet another attempt to enroll her in public schools; she felt hopeless, suicidal, homicidal and depressed. She reported more neighbors watching her and approaching her when she was in her yard. Senators Warren and Markey along with Rep. Clark do not deny their involvement documented via emails.

17. My child was court ordered back to Natick Schools in 2017 or else I had to pay for a private school; she went to private Catholic Schools where she felt safe and flourished without an IEP - she just wanted to be safe with the adults.

The General Principles of Congressional Oversight "investigate alleged instances of poor administration, arbitrary and capricious behavior, abuse, waste, dishonesty and fraud."

Protect Individual Rights and Liberties...

We are food insecure, at risk of losing our home, and continue to be harassed - we are both fully disabled. Framingham, Natick and State Police are involved and it is not safe for us without an investigation. We reserve the right to add to this list -

We care only for the complete and accurate truth - we need an investigation into the wrongdoing.
