Secretary of State - I am seeking information for the permit provided to Karen Vaz on July 11, 2014 - which was issued by the Building Commissioner Michael Tusino.

The ZBA did issue the 2009 permit for the first shed but not the 2014 second shed.

In 2012, according to then inspector James Paolini, he inspected a new addition for a kitchen which required a new footprint of the foundation in the back/rear setback.

Mr. Paolini stated via emails that there were surveyor reports filed for all permits issued.

1. I am seeking any and all information regarding the July 11, 2014 permit issued for the second shed issued by Building Commissioner Tusino -

2. I am seeking any and all information regarding the Building Permit for an addition of a kitchen in 2012

I am seeking any and all information including but not limited to all surveyor reports, memos, documents, photos, public notifications to abutters, public hearings, names of inspectors

who inspected 3 Lilian/Lillian Road.

Mr. Tusino:

I am requesting you respond to this email and not cut/paste response through records custodian. I am filing with FBI to investigate, please cooperate. My child continues to be put in harm's way and both Framingham and Natick Police are involved. State police are also complicit as are Judge Doug Stoddart and numerous others. This appears to be directly related to my reporting fraud in Framingham Schools and Natick Schools.

1. The ZBA gave Karen Vaz a permit for a shed in 2008 - she was required to remove the already installed shed to be in compliance with the setback bylaws.
2. The ZBA gave Karen Vaz a permit for a porch in 2013
3. The Building Department which you were and are the Commissioner - July 11, 2014 gave Karen Vaz a permit for a new larger shed to be installed in the same area which the prior shed was required to be moved - you mailed out the permit without any public notice, no public hearing, no abutters were notified.

You conspired with Karen Vaz to engage in fraud - this was during the same time I was questioning Natick School finances and they excluded Sarah - in a sworn affidavit, emails - Natick claims they relied on my neighbors Karen Vaz and Avi Finder to provide evidence that Sarah did not reside in Natick. Both Avi Finder and Paul Vaz have been seen outside our home videotaping - Avi Finder has a camera on the back of his house pointed at my child's bedroom. You have also provided Mr. Finder with the right to fence in town/city property with full knowledge that I cannot use my yard because of it.

**Are you confirming that Framingham Building Department does not have any surveyor reports filed for the permits issued to Ms. Vaz? Not for the addition of a new kitchen which changed the footprint? Not for the new shed or porch/second addition?**

I have witnessed a car drive slowly by my house at 3:30 am and turn into Lilian Road. I have seen another car taking pictures of my home yesterday - do you know anything about this?

**Mr. Tusino, it appears you conspired with Karen Vaz to file in Land Court against me for the overgrown vegetation which I was unable to maintain due to Ms. Vaz ongoing harassment - it appears she was harassing me because you and she both know the current shed is not in compliance with the setbacks -**

Please confirm receipt of this email and begin to chose to cooperate - my child continues to be put in harm's way and denied an appropriate public education.

Building Commissioner Michael Tusino and Zoning Board of Appeals:

I seek clarification of your responses to my public records requests/ new public records requests:

1. 2008 - Who prevailed in the zoning board of appeals regarding Karen Vaz shed installed at 3 Lillian (Lilian Road) - Current Chair Phil Ottavani was the Chairman in 2008.
2. 2012 - Please confirm that the permit issued for The Vazs' in 2012 was for a kitchen - not a shed per your email response of May 29, 2019. Per email, Inspector James Paolini stated the Vazs had to submit a land surveyor report with a propose to build. Your records response falsely claimed the 2012 permit was for the new shed installed in 2014.
3. 2013 - The Vas' second story addition with front porch also no land surveyor reports or propose to build were required by Commissioner Tusino.
4. 2014 - The July 11, 2014 permit was given by Commissioner Tusino and there was no public notice, no public hearing and no abutters were notified; permit was for a larger shed to be installed in the same area as the 2008 shed which was found to be in violation of the setback bylaws - The new shed is not within the setback bylaws.
5. 2014 - July A collaborative neighbor filed a complaint with the Building Department regarding overgrown vegetation at 230 Prospect Street - Please identify who the neighbor was.

6. 2015 - The permit for the second story addition with porch also did not require a propose to build or a surveyor's report.
7. 2017 - October 10, - Who was the collaborative neighbor who filed a complaint at approximately 2:30 PM regarding overgrown vegetation at 230 Prospect Street?
8. Please confirm any familial relationship of Stephen Meltzer of the ZBA Board and Robert N. Meltzer.
