Dear Ms. Spaulding:

The Commission on Judicial Conduct has received your April 7, 2023 complaint alleging a conspiracy against you by this office, Governor Baker, the Office of Bar Counsel, and several judges.

As this office advised you in its prior letter to you, dated February 2, 2023, the Commission on Judicial Conduct has the power to review actions of Massachusetts State Court judges which may constitute judicial misconduct. This office does not have any authority to intervene in a case, reverse a judge's decisions, or require a judge to recuse himself/herself from a particular matter.

Your April 7, 2023 made claims of conspiracy but failed to provide any evidence to support those claims beyond baseless speculation. Accordingly, this office cannot docket or investigate your complaint.

As this office has also previously advised you, it is improper for you to communicate directly with a member of the CJC about a complaint against a judge that you have filed with this office or that you intend to file. Moreover, this office will not communicate further with you unless you file a complaint that makes a docketable allegation against a judge.
